Franchising

The new franchise law defines the term "franchise" as: the rights granted by the franchisor to the franchisee to carry out the franchise business under the franchisee's own account while undertaking the use of the IP and related trademarks of the franchisor, including providing the technical expertise and technical knowledge of the franchisor, and determining the method of operating the franchising business, in exchange for monetary or non-monetary compensation that does not include the sums paid by the franchisor granting the franchise in exchange for goods or services. Due to the importance of clarifying and detailing the rights and obligations of each of the parties, Shadi Alhozaim Advocates and Legal Consultants has the ability to provide advice and draft the terms of the franchise contract according to the highest quality standards, in a manner that does not conflict with the provisions and articles of the recently issued franchise law.



Licensing and Classification
